The January 2017 Gambling Report was given by Dick Seawell. Bingo Net Receipts were \$1947. Electronic pull-tabs generated \$11,450 Net Receipts. On Schedule LG100F Line 27, profit carry-over for the month shows \$68,443.17. The electronic payout percentage was 85.0%, paper was 85.7%. The Gross Profit was \$39,962. Net profit before taxes was \$26,723. Site profit was \$15,188. As of February 9<sup>th</sup>, Mick Spurrier holds the Gambling License. The staff was made aware of a crime alert addressing counterfeit bills being passed.

# **Secretary's Report:**

### **Treasurer's Report:**

The Treasurers Report for January 2017 was given by Jeff Woodbury. The General Fund balance was \$52,519. The Special Fund balance was \$15,372,339. This includes the pending payouts, as the checks have not been written yet. W-4's are needed from the Board to process payroll. Jeff is working on creating online access for all of our accounts.

Motion was made by Jim Knutson to approve the January 2017 Financial Report. Seconded by Dick Seawell.

#### **Old Business:**

**a.** Mike Cogswell reported \$88.75 collected. One check was written to Cub for \$41.38. The balance with the deposit is \$1027.94. The pop machine at Station 3 is in need of repair. There was discussion on whether or not it is worth investing \$350 into the machine, or replacing it with a refrigerator.

Motion to approve the Pop Fund Report was made by Jeff Scherer. Seconded by Dick Seawell.

**b.** Jeff Hendel reported \$141.00 in sales. Chris Baker spoke to Kelly Piller about their website. They started their site in order to try to provide some consistency while offering updated merchandise to the Maple Grove Firefighters. It was not their intention to compete with the MGFRA site. It was discussed taking over their site. Dick Seawell pointed out that they put time and effort into their site and developed a good-looking site. He thought that rather than doing a hostile takeover, we could allow them to keep their current profits to compensate for the work they have done. Ron Johnson stated that the current logo is owned by MGFRA. He will look the documentation. Scott Anderson added that City is copyrighting their maple leaf logo. Dick made a motion that the Board / Merchandise Trustee start the process of merging their website into our existing platform.

Jeff Hendel will look at merchandising "friends of the MGFD" apparel for sale to non –firefighters.

#### **New Business**

- a. Next meeting Sunday February 26, 2017 at Station 2 7:00 PM.
- b. Charter Member Dave Hamilton and 19-1/2 year firefighter Don Ramstad passed away recently. We will need to get their information in order to make two pavers for the Memorial Garden. Discussion was made to review the existing Flower Policy. It was suggested making a donation from the Charitable Gambling account to the appropriate charities.
- c. The new audit firm requires a token from Wells Fargo in order to process payroll. To do that, Wells Fargo stated we would be moved from a Consumer Account to a Business Account. This would cause us to be charged \$2000+ annually in cash processing fees. We need to find a payroll process that will allow us to do direct deposit without incurring any additional fees.
- d. It was suggested that the organization obtain n a second PO Box key.
- e. The pool table at Station 1 is in need of recovering. It is a slate table that is still in great shape. Currently the stairway door is locked. We will look at getting a fob on the door at the top of the stairs so there is access for all firefighters.
