## Secretary's Report:

# **Gambling Report:**

The April 2017 Gambling Report was given by Mick Spurrier. Bingo Net Receipts were \$2456. Electronic Bingo Net Receipts were \$714. Paper Pull Tabs generated 30,312 with an 84.6%. Electronic pull-tabs generated \$8,138 Net Receipts with an 89.8%. All of that combined for a Gross Profit of \$41,620 and after expenses, a Site Profit of \$14,692 for the month. On Schedule LG100F Line 27, profit carry-over for the month shows \$101,558. We showed a cash overage of \$580.00. I am not sure where that is coming from, I will need to investigate more. The Site Profit has already passed last year's total with two months to go.

#### **June 2017 Allowable Expenses:**

On the Preapprovals for June, Dick salary was lowered to \$500.00 and Micks was increased to \$2500.00. The Minnesota Department of Revenue was increased to \$20,000 and Highland Bank was added at \$100.00.

#### **Treasurer's Report:**

Jeff Woodbury gave the Treasurers Report for April 2017. The General Fund balance was \$45,258. The Special Fund balance was \$14,957,665. Jeff provide the Check Register as well as the Distribution Fund Report, which is used for Payroll as well as Payouts. We received the check for dues. There was a \$2,469.00 check from the City from rebalancing the fund prior to the December payouts. We also received a \$4000.00 check from the State for the Supplemental Payout. Going forward, all Pension Payouts will be made from the Distribution Fund. An electronic transfer will be made from the Special Fund prior to writing checks. Jeff will be able to include tacking of the Golf Tournament proceeds on his monthly report.

a. Mike Cogswell reported \$78.50 was collected. There were two checks written to Cub, \$64.16 and \$81.09. The balance without the deposit is \$1118.56.
