Chris Pidel gave a special fund summery for first quarter. The fund was up 10.72% for the first quarter, for a balance of \$17,493,228, and was up 13.5% year to date as of the meeting. We have \$410,996 in cash, \$2,521,069 in bonds and \$14,561,162 in stocks. Our change in value for first quarter was \$1,704,334. Jeff Woodbury gave the Treasurer's report. The balance of the special fund at the end of February was \$17,493,228. The general fund income for the month of February was \$15, and expenses for \$4,578 for salaries and merchandise orders, for a net loss of \$4,563 and a general fund balance of \$43,741. As a note merchandise orders show up as an expense this month and income the following month.

- a. State statute updates. Beginning in 2019 the fire chief is required to certify service credit by March 31st, firefighters must be provided a copy of this certification 60 prior and have the ability to appeal. There was a new statute to allow firefighters to continue to accrue pension time if they leave their current fire department and join another. You would not get any new monies added to your pension, but would continue to accrue service time. We will look into if this is allowed for defined benefit to defined contribution and vice versa. If we chose to allow this, it would require a by-law change.
- **b.** 2019 Golf Tournament will be on September 8th. There will be a planning meeting coming up soon, and a flyer will be sent out soon as well.
- **c.** Motion made to approve check number 2109 for MSFDA reimbursements, we do not have final total yet.
